## Basic information:

Public Act 97-0609 amended the Open Meetings act, effective January 1, 2012, requiring the posting of salary and benefit information for certain employees. Also, each IMRF employer, at least six days before approving an employee's compensation package that is $\$ 150,000$ per year or more, must post the total compensation package for that employee on its website. The "total compensation package" includes salary, health insurance, housing allowance, vehicle allowance, clothing allowance, bonus, loans, vacation and sick days. District 33 does not provide payments for housing allowance, vehicle allowance, clothing allowance, bonus and loans.
