Leman Middle School Superintendent News

The Superintendent News is to update the board and community on some of the many programs and activities occurring in the schools and the departments determined to help us accomplish the goals of the District Strategic Plan.

Goal #1: Student Growth and Achievement

This year, 7th-grade math teachers began piloting the IXL personalized learning platform in place of Freckle. Our teachers and students have been highly engaged in this new platform, and our 7th-grade math team had one of the highest growth rates in the district on their winter MAP test. Based on this success, we expanded the pilot to 6th and 8th-grade teachers. Teachers in the pilot continue to grow in their knowledge of the program, and students enjoy the change in platform from Freckle. We will continue to monitor our math growth data to determine if this has been a successful pilot, but thus far, we are very pleased.

Goal #2: Learning Culture of Equity, Engagement & Agency

Unified Sports Basketball has been an exciting addition to our athletic offerings for this year! This activity provides an opportunity for our students with disabilities to compete athletically alongside typical peers to encourage friendship and understanding. Our first home game was on Wednesday, March 8th, and we packed the house with students, staff, families, and community members. Unified Sports has truly unified our community!

Goal #4: Family Engagement and Community Partnerships

Collaboration with the high school continues to develop this year.

• In January, I attended the 8th Grade Open House and learned more about the athletics and activities available to our students.
