The regular meeting of the Board of Education was held at Leman Middle School on Thursday, December 1, 2022, beginning at 7:00 p.m.

Public Hearing - Tax Levy

The Board of Education held a public hearing on the 2023 tax levy. Mrs. Karen Apostoli, Director for Business and Operations, reviewed the levy process mentioning that the Board of Education, at its November 17, 2022 meeting, approved the intent to levy taxes for the upcoming fiscal year, and that a notice of this public hearing was published in a local West Chicago newspaper on November 22, 2022. Mrs. Apostoli asked if any member of the public would like to make a comment regarding the 2022 tax levy. No one in the audience addressed the Board concerning the levy. The public hearing was concluded. The 2022 tax levy will be presented to the Board for adoption at the December 15, 2022, regular board of education meeting.

Superintendent News - Currier School

The Superintendent News is to update the board and community on some of the many programs and activities occurring in the schools and the departments determined to help us accomplish the goals of the District Strategic Plan.

Goal #1: Student Growth and Achievement

Currier was excited to recently host a Literacy Squared Learning Lab along with Gary School, thanks to the help of Rubi Ortiz. Currier had four teachers open their classroom doors so that members from other districts could observe them teach using researched based dual language strategies such as the Dictado, Asi se dice, and Lotta Lara. Our teachers were able to receive feedback from Dr. Kathy Escamilla, Dr. Manuel Escamilla, and members from other districts on the teaching practices and their effectiveness. The Currier staff that participated were Laura Arvizu [kinder dual], Daniel Guerrero [3rd-grade dual], Kristy Klich [2nd-grade Gen. Ed.], and Jessica Wanzung [5th-grade dual]. This learning experience helped us continue to reflect on our teaching practices, and the team will share their experience and learning with their grade-level colleagues.

During the recent School Improvement Day, Currier staff was reintroduced to the Dictado by Currier's instructional coaches, Melinda Johnson, and Krisann Castro. Teams collaborated in sharing their understanding and how they have been implementing this teaching strategy in their classrooms. Teams asked for time to continue collaborating in this learning by reviewing student samples together.
